**Ohio Speech and Hearing GAC
Legislative Activities Report
December 2020**

The Ohio General Assembly's lame duck session is nearing an end, as lawmakers are expected to spend the final weeks in December working on priority measures before adjourning. Lame duck session is always a hectic time in the legislative calendar; however, the COVID-19 pandemic has increased the turmoil, with multiple legislative members testing positive and being forced to miss committee hearings and sessions. Nevertheless, Ohio's lawmakers continue to move ahead as they work to pass several major issues by the end of the year, including a \$2.5 billion state capital budget, reforms to HB 6 (the controversial energy policy passed in 2019), criminal sentencing reforms, and several revisions related to education.

Legislation that would institute major reforms to the state's occupational licensing laws has gained traction during lame duck session and continues moving through the committee process. Occupational licensing reform has been one of the major themes of the 133rd General Assembly. The Senate General Government & Agency Review Committee added a number of amendments to SB 246 during its two most recent hearings. SB 246 deals with out of state occupational licensing reciprocity and has received nine committee hearings where it has undergone numerous revisions. A separate bill dealing with occupational licensing is Rep. Koehler's HB 263. HB 263 would revise the initial occupational licensing restrictions applicable to individuals convicted of criminal offenses. The bill is currently pending in the Senate Transportation, Commerce & Workforce Committee where it has had five hearings. It is likely both measures will pass either as stand-alone bills or could be amended into other bills in their entirety.

House Bill 436, which would mandate dyslexia screenings for students continues to be debated in the Senate Education Committee. On December 1st, Chairwoman Lehner offered a substitute bill that, in addition to numerous other changes, would include modifications to the members who would be appointed to the "Ohio Dyslexia Committee" created under the bill. This committee would be instrumental in creating a guidebook for schools to use in developing dyslexia screening programs. The substitute version adds additional members to the committee, including representatives from schools, education service centers (ESCs), the Ohio Department of Education, a parent of a child with dyslexia, a reading intervention specialist, and others. OSHGAC worked with stakeholders on the development of the substitute bill and was happy to see the substitute bill include a speech-language pathologist represented on the committee. Senator Lehner described the substitute bill as a compromise between interested parties. Chairwoman Lehner and Vice Chairman Brenner also indicated additional amendments are being considered, with the goal of passing the bill by the end of the year.

A handful of high-profile health care bills have also received attention in the lame duck session. One of note is HB 679, a telemedicine bill that was introduced in an effort to try to codify administrative rules surrounding the practice of telemedicine that saw a rapid uptick in utilization during the pandemic. The Ohio Senate is signaling that it is not interested in passing HB 679 and instead would defer to the administrative rules that were developed earlier in the year. If the bill does not pass by the end of the year it will “die” and need to be reintroduced in 2021. The sponsor, Representative Mark Fraizer (R-Newark) has indicated that he will be willing to sponsor stand-alone legislation next session should the legislation stall in the Senate. OSHGAC testified in support of HB 679, specifically on the provision of the bill that allows telehealth services to be provided to patients without an annual in-person visit, as required in the Ohio Administrative Code.

Following the governor’s announcement of additional restrictions tied to COVID-19, legislators passed two measures aimed at limiting the power of the executive branch amid the ongoing coronavirus pandemic. The House voted 75-11 to pass HB 621, which would enable businesses required to limit or cease operations by health orders or regulations due to dangerous diseases to remain open if they observe the same safety requirements imposed on businesses not required to be closed or facing restrictions. Also known as the Business Fairness Act, HB 621 addresses disparate treatment between big box stores and small retailers according to joint sponsor Rep. Jon Cross (R-Kenton). HB 621 has been sent to the Senate and has been referred to the Senate Transportation, Commerce and Workforce Committee, chaired by Senator Rob McColley (R-Napoleon).

Similarly, both chambers passed and sent to the governor SB 311—legislation that would allow the General Assembly to adopt a concurrent resolution to rescind certain Ohio Department of Health orders or rules for preventing the spread of contagious or infectious diseases. SB 311 also prohibits ODH from issuing a general, mandatory statewide or regional quarantine order that applies to individuals who have not been either directly exposed to or medically diagnosed with the disease that is the subject of the order. The bill passed both chambers on largely party-line votes. Proponents of the measure say the proposed law changes would provide a needed check on wider orders that impact residents’ civil liberties, lives and livelihoods. Opponents, however, argue that the legislation would harmfully limit health officials’ ability to effectively address infectious diseases and outbreaks. As expected, Governor DeWine vetoed the bill stating, “this bill is not in the best interest of protecting the health and safety of Ohioans.” President Obhof, who originally suggested his chamber would immediately take up a vote to override the veto, has said he continues to meet with the DeWine Administration to discuss changes to Ohio law that would ease the concerns of lawmakers.

House Speaker Bob Cupp (R-Lima) was unanimously re-elected to serve as speaker for the 134th General Assembly. The caucus also announced that Rep. Tim Ginter (R-Salem) will serve as speaker pro tempore; Rep. Bill Seitz (R-Cincinnati) will serve as majority floor leader; Rep. Rick Carfagna (R-Westerville) will serve as assistant majority floor leader; Rep. Don Jones (R-Freeport) will serve as majority whip; and Rep. Cindy Abrams (R-Harrison) will serve as assistant majority whip.

The House Democratic Caucus leadership team will remain unchanged in the 134th General Assembly despite losing seats in the most recent election cycle. Minority Leader Emilia Sykes (D-Akron) will continue to lead the caucus after members held a remote, informal vote. The minority leadership team will also include: Rep. Kristin Boggs (D-Columbus) as assistant minority leader, Rep. Paula Hicks-Hudson (D-Toledo) as minority whip, and Rep. Richard Brown (D-Canal Winchester) as assistant minority whip.

The Senate GOP unanimously chose Sen. Matt Huffman (R-Lima) to serve as president of the Senate for the upcoming G.A. The majority caucus also announced that: Sen. Jay Hottinger (R-Newark) will serve as president pro tempore; Sen. Kirk Schuring (R-Canton) as majority floor leader and Sen. Rob McColley (R-Napoleon) as majority whip.

Senate Democrats selected Sen. Kenny Yuko (D-Richmond Heights) to once again lead the caucus. Sen. Cecil Thomas (D-Cincinnati) will also retain his place as assistant minority leader. Also joining the team are Senator Nickie Antonio (D-Lakewood), who will serve as

minority whip, and Sen. Tina Maharath (D-Canal Winchester), who will serve as assistant minority whip.
