# Does Delta refund taxes on canceled

## tickets?

Taxes and fees such as U.S. transportation taxes, airport improvement fees, and **security charges** are refundable when the flight isn't taken.

## 2. When Delta Refunds Taxes on Canceled Tickets

Delta typically refunds taxes and fees in the following scenarios:



#### A. Refundable Tickets

If you purchased a refundable ticket, you can cancel your flight and receive a full refund, including the base fare and all taxes. The process is automatic if canceled through Delta's website.

## B. Non-Refundable Tickets

For **non-refundable fares**, you won't get back the ticket cost — but you can still claim a refund for unused government taxes and airport fees.

Example: If you booked a non-refundable ticket and canceled it before travel, the **security** fee, segment fee, and airport facility charge are often refunded upon request.

To initiate your refund, call [[23 +1 (877) 394-5034]] and speak with a Delta refund representative.

## C. Delta-Canceled Flights

When Delta cancels or significantly changes your flight schedule, passengers can choose between:

A full cash refund, or

An **eCredit** for future travel.

In both cases, applicable taxes are returned to you.

## D. Duplicate or Overcharged Taxes

Sometimes, duplicate fees are charged during multi-leg bookings. Delta corrects such errors automatically or upon request.

## 3. How to Request a Refund for Taxes and Fees

You can claim your tax refund from Delta through several channels:

## Online (Fastest Option)

Visit Delta's **Refund Request Form** at www.delta.com/refunds.

Provide your:

13-digit ticket number (starting with 006)

Passenger name

Payment method used

Once submitted, Delta sends a confirmation email and tracks your refund progress online.

## 4. Refund Processing Time: How Long Does It Take?

Processing times depend on your payment method and booking type:

Payment Method	Estimated Processing Time
Credit/Debit Card	7–10 business days
Cash or Check	20-30 business days
Third-Party/Agency Bookings	30+ business days

If you haven't received your refund after 30 days, contact [[ +1 (877) 394-5034]] to request an update.

## 6. Expert Tips for Getting a Quick Refund

- 1. Cancel Early: Always cancel before the flight departs to protect your eligibility.
- 2. Keep Your Documentation: Save receipts and ticket confirmation numbers.
- 3. Check Your Email: Refund confirmations and updates are sent digitally.
- 4. Follow Up Promptly: If no refund appears within 10–14 days, call [[23 +1 (877) 394-5034]].
- Avoid No-Shows: Missing your flight without canceling may forfeit your refund eligibility.
- Request eCredit If Needed: If you'd rather travel later, you can convert refunds into Delta eCredits.

When you cancel a ticket, only certain taxes can be refunded. These may include:

**U.S. Transportation Tax (7.5%)** 

Passenger Facility Charge (PFC)

U.S. September 11th Security Fee (\$5.60 per flight segment)

**International Arrival/Departure Taxes** 

#### **Foreign Airport or Customs Fees**

These are government-imposed charges, not Delta's revenue, so when travel doesn't occur, these amounts are usually refundable.

## Q1. Does Delta automatically refund taxes when I cancel my flight?

Not always. Refunds for unused taxes may require a request. To ensure you receive your full refund, call [[23 +1 (877) 394-5034]] and confirm eligibility.

Yes, even though Basic Economy fares are non-refundable, Delta refunds applicable taxes and government fees when the ticket is unused.
